Invitation to the Lusaka Debating League

Dear Coaches and Coordinators,

Greetings from the National Debating League (NDL). We are a South African-based organization that organizes debate competitions for over 220 schools across South Africa, Angola, Zambia, Kenya, Tanzania, Namibia, Botswana, and Mozambique.

We are writing to invite your school to our next championship in Zambia. This will be held at Martin House School, Chisamba, on 7-8 February 2026. An online Orientation and Training session will be held for educators in late January.

Entry is open to schools from across Zambia. To be eligible, students should work in teams consisting of three to five members and be in Grades 4 to A-Levels. Schools may enter multiple teams per division. There are four possible divisions to enter:

Group A: Grades 10+ | Group B: Grade 8-9 | Group C: Grade 6-7 | Group D: Grade 4-5

Top performing teams will earn an invitation to the 2026 Pan-African Debating Championship in Johannesburg. Last year Zambian teams competed successfully at international NDL events. A team of Rhodes Park students competed in Cape Town and reached the finals against Durban Girls' College. A team from the International School of Lusaka were runners up in Johannesburg against St Benedict's College, and a team from Lusaka Oaktree School won the Junior Pan-African Championship in Cape Town. St Ignatius College also performed well at both our Cape Town and Johannesburg events.

The program is designed to help students develop their reading, writing and verbal communication skills. In addition, the debate topics encourage students to learn more about a diverse range of ideas outside of the standard school curriculum. We will work to ensure all debaters become more confident and knowledgeable.

Each team will need to bring a teacher who is willing to adjudicate debates. We will guide them through the process of adjudication with our online training sessions. This training will make the process of adjudication enriching and enjoyable. Many of our adjudicators in South Africa are teachers or school principals. They have commented on how adjudication experience has helped them improve their communication and analytical skills. These skills are especially useful for educators pursuing management positions in their schools.

The registration fee *per student* will remain unchanged from 2025—ZMW 1,400 per debater, and no fees for adjudicators.
